Some other minor changes have been made. The data from owners was provided as either digital data, printed maps, or scanned maps. Paper maps were scanned and forest boundaries digitised, utilising the existing boundaries in LCDB2.

Forest boundaries represent either net stocked area, forest boundary or legal boundary.

Owners had the option of their data not being displayed on this map, hence a few known forests are not shown.
